From the **Director's Desk**

Dr. H Chaturvedi Director BIMTECH

When the academic year started in June 2019, the light seemed to be shining bright on India, especially in the entrepreneurship area. Several new Indian unicorns and gazelles were announced and foreign investment was flowing into many startups. Over 4100+ Start-ups had benefited in 2019, through various programs of the Central Government. The whole ecosystem seemed geared for accelerated growth but then, in February 2020, we were hit by the COVID crisis and it brought an abrupt and catastrophic change in every aspect of life.

The most devastating shocks were borne by the budding startups and the unorganized sector. Even then, the human tendency to prevail portrayed a silver lining after all. In BIMTECH, the focus was catalyzed to shift the processes online. Student interviews happened online and so did the teaching and evaluation! For the first time ever, the education sector was scrambling to find ways and methods to keep the momentum going. The faculty and staff team worked in tandem to find out solutions and within a few days, most processes shifted into the virtual space. Of course, there were a few minor glitches but then everything fell into place. The incubatees from Atal Incubation Centre (AIC) also stepped forward to help combat the COVID situation in their own ways. Some of them helped to create 3D printed ventilator devices for the highly resource-strapped hospitals, while others helped create face masks and PPE kits, and yet others created support communities online. Other interventions in the form of water and food packets for migrant laborers and the underprivileged, were carried by faculty and staff volunteers. Every day, for two months, nearly 1000 people have been distributed food, through the aegis of the campus services.

To address the adverse times and to make sure that the business springs back to their feet, our Government came up with strategies and action plans specifically revolving around startups and small scale businesses. Suddenly, what had seemed like a catastrophe turned into an opportunity as many sectors such as health and FMCG boomed. Many startups changed their business models and pivoted on their revenue streams and quite a few entrepreneurs devised new product verticals during the lockdown. Online Education and web-based courses came up, remote working tools came into play in order to facilitate projects. With the national lockdown active and social distancing as the main method of protection, the E-Commerce industry is already rising and OTT platforms have surfaced as the most common way for entertainment. ACT (Action Covid-19 Team) has set-up a 100 Crore grant for the ideas which could help combat Covid-19, Knowledge portals are established online and incubators across the nation, including our own AIC, are going virtual. The new AIC cohort of the Khoj program, with 11 startups, is being conducted in a completely virtual mode.

Unlike any other calamity in history, this one is likely to haunt us for a long time. The times are surely unparalleled and unprecedented but being resilient and empathetic is the key to overcome this seemingly formidable tragedy.

hroughout human history, crisis have been pivotal in developing our societies. The global COVID pandemic and associated policies restricting people's movements have caused major disruptions to many businesses. We've already observed major shifts in business practices. Even so, the shock rippling through the business world is daunting. With countries accounting for over 50% of world GDP in lockdown, the collapse in commercial activity is far more severe than in previous recessions. The exit path from lockdowns will be precarious, with uneasy consumers, a stop-start rhythm that inhibits efficiency, and tricky new health protocols. And in the long run, the firms that survive will have to master a new environment as the crisis and the responses to it accelerate three trends: an energising adoption of new technologies, an inevitable retreat from freewheeling global supply chains and a worrying rise in well-connected oligopolies.

Where there are challenges, there are hidden opportunities. It is also true that throughout history, terrible events have led to great transformations. The bubonic plague of the 1300s led to the modern employment contract. Cholera epidemics of the mid-1800s gave us urban parks and radically improved infrastructure. The 1918 Spanish Flu revolutionized healthcare. Entrepreneurs are hoping to mine shifts in consumption patterns and behaviour. The public health crisis is unearthing existing structural problems in capital markets, the economy and society as a whole. Industries have turned in droves to Artificial Intelligence (AI) and AI is no longer about the future. It's about the present and it's interesting to see what the clinical and business leaders are doing now to leverage this next big shift in healthcare's computing platform.

At its core, the pandemic also reveals a basic dichotomy in what kinds of innovations are desirable by society. Exploitation means getting more out of what we already have built. Exploration is about finding entirely new things. Markets have tended to favour exploitation, chasing surer bets and smaller gains. Massive amounts of venture capital have been poured into disruptions like WeWork, Uber or e-scooters, companies that focus less on grand social challenges but rather on reworking existing categories. Exploratory technologies like medical diagnostics have received relatively little venture capital attention. The crisis has put this massive misallocation of funds into sharp relief.

But on the positive side, biggies such as Google initiated Work from Home for the entire year and Twitter stated Work from Home for their entire lifetime! This has reaped many benefits and has encouraged others to follow the same path. Statistics showed that employees working remotely were happier and productive than they were during old normal work routines and companies saved a lot of money by not operating their workplace buildings.

Similarly, supportive environments are increasingly essential to successful entrepreneurship and these are evolving across the world. It is at this juncture that the Centre for Innovation and Entrepreneurship Development (CIED), under the aegis of BIMTECH, is working to create the support systems required by students and the larger community in Greater Noida and we look forward to your continued support and encouragement of this initiative for entrepreneurship.

Centre's Annual Report on ENTREPRENEURIAL INITIATIVES, **ACTIVITIES & ACHIEVEMENTS**



Executive Summary

Established in 2009, the Centre for Innovation and Entrepreneurship Development (CIED), aims to prepare men and women to lead, innovate, and think entrepreneurially in business, public and social service, to be job creators and role models. For the past 11 years, we have inspired, educated, and empowered potential entrepreneurs as they innovate and create business ventures. Our mission is to support and mentor the entrepreneurial ambitions of BIMTECH students, alumni, faculty and the community at large and turn BIMTECH into a crucible for entrepreneurship initiatives. We do this by providing inspiration, driving team formation, and facilitating venture development. These days, great business ideas can come from anywhere. To encourage them, we need to increase the breadth and depth of the entrepreneurial ecosystem by multiplying connections among entrepreneurs and mentors, improving access to entrepreneurial education, creating events and activities that activate all the participants in the start-up community, and much more.

In congruence with this core idea, in the last academic year of June 2019 to June 2020, the Centre carried out various activities. They are collated under 7 heads, viz.

June 2019- June 2020



- 1. Advisory Board of the Centre: For the academic year 2019-20, CIED had 13 Advisory Board members.
- 2. Members of the Expert Panel of Mentors: The Centre has created an expert Panel of Mentors to support the budding entrepreneurs. The Centre is utilizing the services of eleven mentors for this initiative.
- **3.** Atal Incubation Centre- BIMTECH: The institute was one of the first ten selections out of the 3658 first-round applicants for Atal Incubation Centres by the Atal Innovation Mission (AIM), in 2016-17. AIC- BIMTECH is one of a kind academia-industry-government partnership, driven by AIM, to create high-class incubation facilities with suitable infrastructure in terms of capital equipment and operating facilities. AIC-BIMTECH is working on a three-stage incubation process for the incubatees, viz. Khoj, Gurukul, and Udaan. Since its inception on 20th January 2018, it has hosted 63 incubatees. On June 1, 2020, AIC BIMTECH started its first virtual program for 11 startups.

4. COVID Warriors

Few of our brilliant incubatees came forward to support our country against the difficult circumstances that emerged due to COVID Crisis. We are proud to share their seamless efforts.

a) Probano: While the economy degraded, employees were laid off by so many firms. This startup brought together accomplished professionals belonging to different functions and organized more than 85 online career counseling sessions all over India. Their motive was to guide people and inspire them to tackle current career obstacles.

b) Uneako Green Pvt. Ltd: In order to safeguard our brave health workers, policemen, and COVID volunteers, their team designed a face shield by the name 'SN19'. The product provides complete facial protection, is comfortable to wear, and offers clear visibility.

c) Ypanx Technologies Pvt. Ltd: To counter the huge requirement of ventilators, this startup utilized the knowledge shared by the 3-D printing community spread across the world and developed 3-D Ventilator Splitter. The device is capable of treating two patients at a time by increasing the capacity of the vent.

d) Concis: They came forth with one of the noblest solutions for those who lost their jobs. The firm connected with almost 500 individuals from Fin-tech and financial service industries, trained them online, and offered them Report editing jobs.

5. Special Initiatives

We never miss out on opportunities that tend to evoke innovations and can strengthen the Entrepreneurial Culture. This year's special initiatives included-:

a) B K Birla Global Innovation Challenge (BGIC 2020): It is the International Global challenge organized in the memory of Late Shri B K Birla. With over 900 applications received and along with a diverse panel of judges and esteemed partner firms, 20 finalists pitched their Innovations for the cash prize of INR 10 lakhs and incubation support and benefits. The winner was Miraqules Medsolutions Pvt. Ltd. for their Synthetic clotting innovation, the first runner-up was Fluid Robotics for AI-based water infrastructure solutions and the second runner-up was Torus Robotics Pvt Ltd for new generation electric motors and dual controllers.

b) First Founders Program: AIC-BIMTECH in association with Foundation for Innovation and Technology Transfer (FITT) and Huddle, launched a free-to-apply program for Young founders of the country. The five-month program focussed on structuring the ventures of the enrolled founders and will end with a demo day to attract the investors.





c) Khoj Program: Regardless of the unforeseen COVID issues, we received more than 65 applications this year. After a detailed assessment of each application, we filtered out 11 of these to be our new incubatees. Their business ideas are related to Agriculture, Information Technology, AI, Education, Food, and Automobile sectors. The program commenced on virtual platforms and is in the process of transforming each incubatee to a business firm.

6. Academic Activities a. TATA SOCIAL CHALLENGE

Institute in association with IIM Calcutta, TATA, and School for e. YOUNG ENTREPRENEURS MEET Social Entrepreneurs India conducted the TATA Social Young entrepreneurs Mr. Aditya Bose, Founder, Ceretonin Enterprise Challenge "Thinking Social" a one-day seminar on Education Private Limited (Probano) & Mr. Rohit Singh the campus on 10 August 2019. The primary objective of this Chauhan, Founder, TGN Internet Private Limited (Bummary) seminar was to build awareness, interest, and desire to had interacted with the students on 6 November 2019. b. UDYAMI 7.0

Udyami 7.0 is the 7th edition of the Biggest Business Carnival of BIMTECH. It is a platform for all those people out there who dare to bring their ideas to the table and test their practicality and feasibility in the real environment. It offers the title of STARPRENEUR to the team that is capable enough to bend the market uncertainties in their favor to earn the best out of the opportunities present.

The annual spirit of entrepreneurship event served as a celebration of the hard work and the culture that has been set up by the Entrepreneurship cell in collaboration with AIC-BIMTECH.

c. E-LEADER WORKSHOP

The E-Leader workshop was conducted by the institute in association with Wadhwani Foundation on 5th October 2019. E-leader Workshop (ELW) is a highly experiential one-day program for a select group of students and E-leaders who have been nominated by their institutes. The participants of this program went through facilitated sessions, self-study, and experiential learning in three phases: Preparation, Training, and Implementation.

d. VYALIKH

"VYALIKH", a write-up competition was organized in Birla Institute of Management Technology, Greater Noida on 15 October 2019. The event was conducted to commemorate our ex-president, Bharat Ratna awardee, Dr. A.P.J. Abdul Kalam who pioneered in the fields of defense research and made contributions to developing some extraordinary innovations. As a part of the MHRD Innovation Cell's "Innovation day" campaign, the E-Cell of BIMTECH organized this event as a write-up competition to promote divergent thinking and to catapult the innovation within and among the students.

About Atal Incubation Centre- BIMTECH

Atal Innovation Mission (AIM): It is a Government of India endeavour to promote the culture of innovation and entrepreneurship, driven by Niti Aayog. AIM supports the establishment of new incubation centres called Atal Incubation Centres. Birla Institute of Management Technology (BIMTECH) was selected as Atal Incubation Centre- BIMTECH (AIC- BIMTECH), for turning the vision of Atal Innovation Mission into reality. The institute was one of the first ten selections out of the 3658 first-round applicants. AIC-BIMTECH is one of a kind academia-industry- government partnership, driven by Atal Innovation Mission to create high-class incubation facilities with suitable infrastructure in terms of capital equipment and operating facilities. It is coupled with the availability of sector-wise experts for mentoring the start-ups so that these startup businesses can become successful entrepreneurs and enterprises.

Atal Incubation Centre BIMTECH has supported 63 Startups to date since its operations started in January 2018. Built over a total area of 16.500 sqft. it also offers a facility of co-living space to its incubatees, AIC-BIMTECH has created 276 iobs via the incubated startups supported till date. It has 61 partnerships, 27 mentors and 9 incubatees who have raised funds. The innovation here lies in the focus on the creation of sustainable businesses through various public and private partnerships by providing market access and capital.

An increasing number of non-profits and social enterprises recognize the importance of being financially sustainable in their business practices. However, despite being fiscally sustainable, many of such impact organizations (in particular, the small to medium-sized organizations in Asia) are unable to scale their impact due to the lack of capital.

The solution is GivFund, a social business fund that crowdsources donations from individuals. An idea spawned from a conversation with Muhammad Yunus, GivFund is an online platform where crowdsourced donations are loaned as interest-free loans to small-to-medium size social enterprises and non-profits in Asia. Once returned, funds will be reused and donors would once again be able to choose to whom to loan returned funds to. This way, the money which would otherwise be donated for one-off impact would be used to create sustainable impact.

About The Event: Udaan

About the Event: BIMTECH STOCK EXCHANGE

The BIMTECH stock exchange is designed as a virtual game and is conducted for three days i.e. from 10 February to 12 February 2020 to provide an experience to the students about trading and investing their money. As the saying goes "earning money is easy but, spending it wisely is tough", this mock exchange has provided students with the first-hand experience of investment in stocks and its challenges.

The companies that are listed on BIMTECH stock exchange are the startups which students came up with as a part of UDAAN. Thereby making the two events coordinated.

The stock fluctuations are done based upon a company which is listed in NSE and has similar USP, business model of the startups. Each startup has its own assigned company to make the stock fluctuations. The entire game was conducted on WhatsApp group. After registering, each participant was sent an invitation to join a WhatsApp group which includes stockbrokers who are basically from the E-CELL team and these brokers run the transactions on behalf of the participants.

A total of 67 students had participated in this virtual game trading for three days and had invested up to 15,00,000 of virtual money. At the end of the game, each participant had been paid the profit money earned by them equivalent to their respective virtual money.

The winners are decided based on the profit percentages and also the money invested by them. The money investment is taken into consideration as it shows the willingness to take the risk and its management by the candidate. The participants' grades are decided based on 70% weightage for-profit percentage and 30% weightage for money invested.
