1. Centre for Sustainability and CSR

The Centre for Sustainability and CSR (CSC) at Birla Institute of Management Technology (BIMTECH), strives to advance the agenda of Sustainability and CSR through

- · Academic engagement;
- Outreach with the society and community;
- Addressing social problems;
- Providing consultancy services to the corporates;
- Capacity building of CSR and Sustainability professionals.

The affairs of centre are managed by Chairperson and faculty members under overall guidance of Dean and Director of the institute.

For having a sharp focus, BIMTECH has nurtured Ranganathan Society for Social Welfare and Library Development, a society registered under Societies Act 1860 and BIMTECH Foundation, a trust registered under Indian Trusts Act, 1882. Both are CSR arms of the institute and undertake social initiatives having separate governance structure.

The Ethos of Social Responsibility at the Birla Institute of Management Technology (BIMTECH)

The ethos of social responsibility at the Institute is no different from the value system of the House of the Birla's, one of the oldest and the most respected industrialists in India. The Institute is modern and progressive in its outlook but retains its deep commitment to simplicity, respect, sensitivity and care for others and zeal to contribute positively to the progress of society.

The Institute exercises the tenets of ethics in its interactions and engagements with its various stakeholders.

Demonstrating the Universal Principles of Responsible Business Management, PRME and Sustainable Development

The Institute has adopted the Principles of PRME which are inspired by internationally accepted values, such as the United Nations Global Compact's Ten Principles, and provide an engagement structure for academic institutions to advance social responsibility through incorporating universal values into curricula and research. The principles help management institutions to seek and establish a process of continuous improvement in order to develop a new generation of business leaders capable of managing the complex challenges faced by business and society in the 21st century.

2. Developing the capabilities of students to be future generators of sustainable value for business and society at large and to work for an inclusive and sustainable global economy

i. Social Project Experiential Learning

The Responsible Business course has been integrated with an experienced based learning through "Community Immersion Programme".

The students are taken for a visit to nearby villages as well as CSR project sites (usually villages) of some of the corporate. Also, the students may choose to work on Social projects as part compulsory short-term projects undertaken by students during the course of their study. The students are assisted to be hand-held by companies. foundations and NGOs with which the Institute has relationship with. Newer organisations come in touch with BIMTECH each year and these associations broaden the base for students to choose and work with organisations of their liking.



The students interacts with CSR heads and field officers of the companies while visiting their CSR Project Intervention sites as well as with the gram pradhans, members of the community, school children, and targeted beneficiaries (of CSR projects of Companies). During the academic year 2017-18, about 400 students visited 18 villages. The details of the villages can be seen at Annexure 1. The students interacted both formally and informally with various stakeholders of the company associated with their CSR projects of sanitation, education, infrastructure, and health and poverty alleviation. The exposure helped students gain significant insights into the social landscape of our country as well as the efforts of companies undertaking CSR projects, as per the mandate of Companies Act, 2013.

Major achievement:

Besides providing the students a flavour CSR initiative of the several companies and developmental gaps in rural India, this year's experiential learning project also resulted into the perception mapping of CSR initiatives of NTPC in six villages near to its Dadri plant. A detailed report was submitted to the CSR department of NTPC Dadri. The report was highly appreciated by the department and the concerned officials expressed intent to use the findings of the report for annual audit. Thus the project has created a win-win situation for the students, the centre and NTPC Dadri.

ii. Business sustainability course:

A new module on Business sustainability has been introduced in all the PGDM programmes.

iii. Session on Sexual Harassment

A session was organised for the first-year students of PGDM on sexual harassment by BIMTECH in collaboration with Thinkthrough Consulting Ltd. (TTC) 38 students attended the one-day session.

iv. 8th Subir Raha Memorial Lecture

BIMTECH students attended 8th Subir Raha Memorial Lecture delivered by Dr. R.A. Mashelkar, F.R.S., President of Global Research Alliance, Former Director General of Council of Scientific and Industrial Research (CSIR) on theme "ASSURED Inclusive Innovation: Path to CSR 2." The event took place at ONGC Limited, New Delhi on Friday, July 13, 2018.

3. Towards Creating Educational Frameworks, Materials, Processes and Environments that enable Effective Learning Experiences for Responsible Leadership

In its role as an academic Institution, BIMTECH strives to contribute towards Creating Educational Frameworks, Materials, Processes and Environments that would enable Effective Learning Experiences for Responsible Leadership. Through its partnerships with institutions and organisations which are working in the domain of sustainability, responsible business and CSR, it facilitates and supports dialogue and debate among educators, business, government, consumers, media, civil society organizations, and other interested groups and stakeholders on critical issues related to global social responsibility and sustainability.

Through its Consultancy and Advisory services, the Institute serves to extend its knowledge to managers of business corporations in meeting their challenges of social and environmental responsibilities by jointly exploring effective approaches.

Conceptual and empirical research advances the Institute's own understanding about the role, dynamics, and impact of corporations in the creation of sustainable social, environmental and economic value and to disseminate it to the larger public.

i. Partnerships

Partnership with Thinkthrough Consulting (TTC)

A MoU was signed between BIMTECH and TTC on 16th of August 2017 to deepen the Institute's footprint of Responsible Business and CSR. Think through Consulting offers advisory services in areas such as Sustainability and Climate Change, Ethical Business, CSR and HR. It is quite a name to reckon with in this domain both nationally and internationally.

The partnering organisations have agreed to collaborate on conducting trainings, workshops, seminars etc. for BIMTECH students and third parties on compliance to the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal Act, 2013) and other empowering provisions for women at the workplace.

Unnat Bharat Abhiyan

BIMTECH has been selected as Participating Institute (PI) under the Unnat Bharat Abhiyan (UBA) 2.0. UBA is a flagship programme of the Ministry of Human Resource Development which intends to enrich Rural India. The programme envision to involve the reputed higher educational institutions of the country in the process of indigenous development of self-sufficient and sustainable village clusters in tune with the notion of 'Grām Swarāj' propounded by Mahatma Gandhi.



All participating institutions (PIs) are expected to establish a UBA Cell which will be responsible for carrying out the activities of the UBA. This will involve the development of an active working group consisting of motivated faculty members drawn from various disciplines. Further, PIs are also expected to identify at least five villages to carry out the out the activities of the UBA. BIMTECH has identified Neemka Shahjahanpur, Alli Ahmadpur Urf Garhi, Bankapur, Khwajpur, and Mahvalipur village in block Jewar of Gautam Buddha Nagar district of Uttar Pradesh. The village and household survey as well as participatory situation analysis will be done shortly to develop development plan for each village.

4. Values of Social Responsibility

Ranganathan Society for Social Welfare and Library Development (RSSWLD) which came into existence in 2009, is a non- profit organization mainly focusing on development of libraries in rural areas. Its main goal is to make the under privileged sections of the society capable of availing employment opportunities. The vision is "To improve the proficiency level of rural students by providing essential educational resources."

The society is working towards opening libraries in secondary schools in key villages and jails across India, motivating under privileged students in villages to develop reading and learning skills so that they can avail competitive employment opportunities and lead a dignified social existence.

i. Establishment of Libraries

a) BIMTECH Pustakalaya established at Man Mandir, Barsana, Mathura

Birla Library inaugurated by UP Chief Minister Shri Yoqi Adityanath and Haryana Chief Minister Shri Manohar Lal Khattar in Barsana, Mathura on February 24th, 2018 It was a memorable day for BIMTECH when Chief Ministers of UP and Haryana in the presence of other ministers and higher dignitaries launched the BIRLA Library on February 24th, 2018 at Man Mandir, Barsana, Mathura. The director of BIMTECH, Dr. H. Chaturvedi explained to both Yogi Adityanath Ji and Shri Manohar Lal Khattar about BIMTECH's unique initiative of opening libraries at district jails of Uttar Pradesh and also helping in providing the necessary elementary education facility to the girls of neighbourhood villages under the project "Protsahan Chiraiyaa" by BIMTECH Foundation and Ranganathan Society for Social Welfare and Library Development (RSSWLD), the CSR wing of BIMTECH.



With the collective initiatives of BIMTECH Foundation and RSSWLD along with the inauguration of this library at Mathura, now BIMTECH is running several libraries in district jails of UP spread in 10 villages and 6 districts across the state.

The institute is planning to add 4 more libraries in jails under this noble initiative.

b) BIMTECH Pustakalaya established at district Jail, Agra

ii. Project Protsahan Chiraiyya

Project "Protsahan Chiraiyya" is a rural social project on women empowerment started by the Society at Neemka Shajahanpur, Jewar Tehsil, UP. This village is adopted by the Hon'ble Union Minister of Culture and local MP, Dr. Mahesh Sharma under the Sansad Adarsh Gram Vikas Yojna. The project was launched with the vision to



sensitize the rural underprivileged adolescent girls about all aspects of good quality life, education, health as well as their roles in the community. The pilot phase of this project was flagged off on 28th March, 2016 to commemorate the first death anniversary of Dr. Sarla Devi Birla, "Founding member of BIMTECH".

RSSWLD has continued to increase the outreach of its project "Protsahan

Chiraiyya", as on date 150 girls have taken course on "life skills" while 60 girls have

attended the course on English speaking. The fifth batch of Project Protsahan Chiraiyya was launched on 17th September 2017.

She also felicitated 20 Girls who have scored 100% attendance. She also encouraged the girls to aspire to self-awareness and identity.

Annexure II: Proceedings of Workshop on "CSR for Agricultural Development"

A National Workshop on "Corporate Social Responsibility for Agricultural Development" was organised by MANAGE in collaboration with Birla Institute of Management Technology during 4-5th July, 2017 at MANAGE, Hyderabad, with an overall objective of providing space for Corporates, NGOs, Academia, State Department of Agriculture and allied Sectors for leveraging Corporate Social Responsibility (CSR) funds for Agriculture Development. A total of 48 delegates from 15 states representing International and National Institutes, State Agriculture and allied Departments, KVKs, Corporates, NGOs etc., have participated in the Workshop.

The Workshop was inaugurated by Smt. V. Usha Rani, IAS, Director General, MANAGE. In the inaugural address, the Director General has shared her vast experiences in the field of Agriculture and provided insight on the perception of people and Government towards each other and gaps in service delivery mechanisms and the reasons thereof. She also elaborated the need for CSR spent on Agriculture and reasons for corporates to work with Institute like MANAGE for the development of Agriculture. The Director General also released the Reading Material of the Workshop consisting of regulatory framework of CSR, emerging trends, success stories and best management practices on CSR in Agriculture.

The technical Session was started with Overview on Regulatory framework of CSR and emerging trends by Prof. N.N.Sharma. He has given an insight on Section 135 of the companies Act, 2013 Corporate Social Responsibility (policy), Rules 2014 and detailed analysis of overall CSR spending by Corporates and spending in Agriculture during the Financial Year 2014-15 and 2015-16.

The other technical sessions were categorized into five groups. Each group consists of 3-4 success cases of Corporates and other stakeholders. Each group was chaired by experienced Delegates and experts from within and outside MANAGE. The experts/Practitioners have shared their experiences with regard to CSR initiatives in Agriculture.

At the end of the First day, the delegates have been formed into five groups and they have been assigned a task of bring out a Roadmap for taking forward CSR activities in Agriculture sector. The leader of each groups have made a presentation about their group member views on the task given.

Panel discussion was conducted with three member panellists chosen among the lelegates to discuss on Identification of activities, Up scaling, Partnership and Innovations. The first day cases were discussed and summed Up by Mr. Vivek Singh and the second day program was summed up by Dr.N. Balasubramani.

The following are the suggested Roadmap by the delegates for taking forward the CSR intervention in Agricultural sectors.

- ✓ A Special Purpose Vehicle (SPV) for promoting CSR activities in agriculture and extension may be initiated at national level in non – profit organization like MANAGE.
- ✓ The CSR fund for agriculture and allied sectors may be channelized through SPV in Consortium approach with the involvement of various partners
- ✓ Consortium approach may be supported and guided by the Steering Committee
- ✓ Steering Committee shall have a broad based representation and participation of various stakeholders such as Representatives of Donor agencies, Agricultural and allied department officials, Representative of implementing partners and farmer representatives.
- ✓ Steering committee shall evolve Vision, Annual agenda and Reach out to Business and Industry Associations, Share experiences of existing projects and prospective of CSR spent in agriculture
- ✓ Steering Committee shall receive the proposals from the implementing agencies across the country, scrutinize the proposal and approve the suitable proposal based on the relevance, importance and technical soundness of the proposal and release the fund accordingly.
- ✓ Funds from Donor agencies/companies/departments shall be received by Consortium.
- ✓ A proper Monitoring system shall be put in place at national, state and project level for
 effective monitoring of implementation of the project including the delivery of input
 and other services.
- ✓ The steering committee shall meet periodically to evolve and pursue the mandate of CSR for agricultural development, scrutinize and approve new proposals, review the progress of implementation of the sanctioned projects.

- ✓ Agriculture is subsumed under 13 items of Schedule VII, and hence, Agriculture yet to attract the attention of India's CSR. Therefore, Agriculture should be added as a separate activity as a priority sector among the activities enumerated in Schedule – VII of the Act like the Swachh Bharat Mission, Clean Ganga Mission, and Slum Area Development and get Agriculture on the radar of CSR.
- ✓ A neutral and non profitable organisation should facilitate to create favourable ecosystem for stakeholders of CSR for Agricultural development and make CSR spend a catalyst for transforming agriculture, Thereby, partner companies may offer services to agriculture sector through their CSR Policies, Objectives, and Strategies and increase share of CSR spend in agriculture. Therefore, CSR cell may also be created at MANAGE, CSR cell may facilitate in getting the appropriate and relevant proposals from the State department of Agriculture and allied sector, KVK etc., and the same will be forwarded to the corporates who is willing to fund such projects.
- ✓ Knowledge bank may be created to share experiments, learnings, best practices that will add value to the future CSR spend.
- ✓ Sharing of best CSR practices among various stakeholders by organising the workshops and seminars at regular interval.
- ✓ Identification of a common geographical area to undertake CSR projects in agriculture.
- ✓ All the members of the consortium shall provide their technical, financial and other inputs based on individual expertise and initiate a few high impact projects.
- ✓ Online platform (csrforagri) may be created, gaps in the field and potential needs of the farmers may be posted and updated regularly for the attention of corporates to facilitate/ CSR spent.
