Project Overview

This ICSSR-funded research project aims to examine the role of NGOs in promoting digital equity among rural women in selected districts of Uttar Pradesh. With India pushing forward its Digital India agenda, a significant digital divide still persists in rural areas—particularly among women. NGOs have been at the forefront of enabling digital access and inclusion at the grassroots level. This project identifies, documents, and evaluates such interventions to understand their effectiveness and the barriers they face.

Objectives

Project Objectives • To identify NGOs' role in reducing the digital divide. • To examine major challenges faced by NGOs in implementing digital inclusion. • To identify the role and effectiveness of NGO-led interventions. • To assess rural women's access to digital tools and platforms. • To measure the gender digital divide in selected districts of Uttar Pradesh.

To understand social, emotional, and infrastructural barriers to digital inclusion.
To create a benchmark for evaluating project impact in later stages.

Methodology:

The project adopts a multi-case study approach involving:

- In-depth interviews with NGO founders, staff, and rural women beneficiaries.
- Focus groups with stakeholders, experts, staff of NGO and Rural Panchayat and Beneficiaries
- Analysis of publicly available documents such as annual reports and impact assessments.
- Survey of control and experimental group of rural women beneficiaries, NGO workers
- Ethical field observations in NGO-led digital literacy sessions.

Significance:

This research contributes to both academic and policy discourse on digital equity, aligning with India's *Vision Viksit Bharat*@2047. It recognizes NGOs as crucial actors—not merely data sources—but partners in development who's on-ground insights and models can be replicated or scaled.

Scope of Work

The selected agency will be responsible for:

- Identification of NGOs and interviews of NGO leaders, field workers and beneficiaries
- Conducting **surveys** across **rural locations** in Uttar Pradesh selecting areas for control groups and experimental groups where NGOs are working
- Administering questionnaires designed by the project team for beneficiary survey and creating questionnaire for NGO workers
- Collecting Qualitative data through interview and focused group discussions
- Recruiting and training field investigators/Enumerators
- Ensuring data quality through supervision and field-level quality checks
- Submitting clean, coded, and verified data in Excel/SPSS format
- Submitting summary report of data collection (dates, locations, field team size, challenges)

Tasks and Responsibilities (Customized for ICSSR Project)

The agency/consultant, will be responsible for the following tasks and deliverables as part of the ICSSR-funded study titled "Making Rural Women Digitally Capable: Examining NGOs' Role in Enhancing Rural Women's Digital Equity in Selected Region of Uttar Pradesh."

 - 1. Village Selection using Treatment-Control Framework
 - Select two sets of villages:
 - a) Treatment Villages where NGOs are actively working on digital empowerment,
 - b) Control Villages with similar socio-economic profiles but no NGO presence.
 - This purposive village selection is critical for minimizing confounding variables and enabling quasi-experimental comparisons.
 - 2. Stratified Sampling of Respondents
 - Within each village, respondents should be selected using stratified sampling to ensure representation across:
 - Education levels
 - o Caste/Social categories
 - o Household income levels
 - o Mobile and internet access
 - This will ensure diversity and comparability in both treatment and control groups.

- 3. Sample Size and Balance
- Ensure that the number of respondents is balanced between treatment and control groups.
- Maintain adequate sample size to support statistical matching and valid inference using PSM.
- 1.6. Plan for Field Work
- 1.7. Fieldwork timelines and logistics
- 1.8. Data collection tools report
- 1.9. Data analysis

2. Primary Data Collection:

Field visits will be conducted in selected districts of Uttar Pradesh. During this phase:

- 2.1. In-depth interviews will be conducted with NGO founders (expected no. 5-10), field staff (intermediaries) (expected no. 10-15), and rural women beneficiaries (expected no.20-30)
- 2.2. Focused Group Interview should be conducted NGO staff
- 2.3. Conducting Quantitative Survey with both Control group (who didn't digital training with NGO's) (expected no.750) and Experimental groups (Who are beneficiaries of training of NGO's) (expected no.750).
- 2.4. Limited support may be requested from NGOs for administering survey questionnaires among the beneficiaries.
- 2.5. Field notes and Key findings
